GENERAL INSTRUCTIONS, ESSENTIAL INFORMATION AND CLARIFICATIONS:

- 1. Only online applications with required uploaded enclosures will be accepted. Applicants must send **Two** hard copies of the application on or before **09/11/2022** till **5:30 p.m.** alongwith all self-attested testimonials, certificates and all supporting documents related to Academic Performance Indicators (API) wherever required or else the application will not be considered. Applicants must produce original testimonials, certificates and other documents at the time of interview, if called.
- 2. The Last Date for receipt of Online Applications is fixed as **04/11/2022** till **5:30 p.m**.
- 3. The candidates must possess the required qualifications as on last date fixed for receipt of online applications in the notification by the University i.e. 04/11/2022 till 5:30 p.m.
- 4. Candidates for the post of Professors and Associate Professors must fill-in and attach Academic Performance Indicator (API) based, Performance Based Appraisal System (PBAS) alongwith the print out of Online Application form, failing which the applications will be summarily be rejected.
- 5. Experience and qualification will be reckoned as on last date for submission of applications. No updating of qualification and experience will be entertained after the last date.
- 6. Applicants are advised to submit the applications to the University well in advance without waiting for the last date to avoid postal delay or any delay due to other unforeseen events or circumstances. The University will not be responsible for any postal delay at any stage.
- 7. The applicant must ensure that he/she fulfils the eligibility conditions for the post.
- 8. The candidates who are eligible as per the UGC Regulations, 2018 (Minimum Qualifications for Appointment of Teachers and Other Academic Staff in University) and/or for Subject of Education NCTE Regulation, 2014 only need to apply.

- 9. The time taken by the candidates to acquire M.Phil. and/or Ph.D. degree shall not be considered as teaching/research experience to stake claim for appointment to the teaching positions. Further the period of active service spent on pursuing Research Degree simultaneously with teaching assignment without taking any kind of leave, shall be counted as teaching experience for the purpose of direct recruitment.
- 10. Excellent academic background, high quality publications, potential to get research funding from Government agencies and industries, appropriate academic professional activities undertaken, and a good innovative teaching record would be some of the important criteria for selection.
- 11. The candidates applying for the posts of Professor/Associate Professor must enter the relevant Research/Academic score as per UGC Regulation 2018. The Research score provided against the given categories in each column must be supported by documentary evidence, without which no claim on account of Research/Academic score would be entertained.
- 12. Candidates applying for the post of Professor & Associate Professor shall necessarily submit self-attested copies of top ten (Two copies each) & top seven (Two copies each) full-length research papers and preliminary pages of books respectively, along with their applications.
- 13. Candidates shall enclose self-attested copies of certificates towards the evidence of Age, Educational Qualifications, Caste, Physical Disability, Experience, etc. with the applications.
- 14. Candidates who desire to apply for more than one post will be required to submit separate Online Applications on the prescribed format alongwith all the specified supporting documents and additional application processing fee alongwith each application.
- 15. The University reserves the right to fill or not to fill any or all the posts, without assigning any reason and no notice will be issued in this regard.
- 16. The University shall verify the qualifications and documents submitted by candidates at any time, at the time of appointment or during the tenure of service. In case it is detected that the documents submitted by the candidates are fake or the candidates have undesirable clandestine antecedents/background and have suppressed the said information, his/her services shall be liable to be terminated.
- 17. In case of any inadvertent mistake in the process of selection which may be detected at any stage even after the issuance of appointment letter, the

- University reserves the right to modify/withdraw/cancel any communication made to the candidates.
- 18. The reservations/relaxations policy for SC/ST/SEBC/PwBD Candidates will be provided as per the existing Govt. of Gujarat policy.
- 19. A relaxation of 5% shall be allowed for the candidates belonging to Scheduled Caste/Scheduled Tribe/Other Backward Classes (OBC)(Non-creamy Layer)/Differently- abled ((a) Blindness and low vision; (b) Deaf and Hard of Hearing; (c) Locomotor disability including cerebral palsy, leprosy cured, dwarfism, acid-attack victims and muscular dystrophy; (d) Autism, intellectual disability, specific learning disability and mental illness; in Multiple disabilities from amongst persons under (a) to (d) including deaf-blindness) for the purpose of eligibility and assessing good academic record for direct recruitment. The eligibility marks of 55% marks (or an equivalent grade in a point scale wherever the grading system is followed) and the relaxation of 5% to the categories mentioned above are permissible, based only on the qualifying marks without including any grace mark procedure.
- 20. A relaxation of 5% shall be provided, (from 55% to 50% of the marks) to the Ph.D. Degree holders, who have obtained their Master's Degree prior to 19 September, 1991.
- 21. Reservation for SC, ST, OBC and EWS will be as per existing Government of Gujarat norms as amended from time to time. Candidates applying for the reserved posts should clearly state to which category they belong to. They must also enclose a Certificate issued by Tahsildar/Mamlatdar/Mandal Revenue Officer/Equivalent authority as proof to this effect without which the application will not be considered.
- 22. The candidate belonging to any of the reservation categories has to submit the respective certificate duly issued by the authorities of Govt. of Gujarat, as case may be.
- 23. Candidates applying for the post(s) reserved for SEBC, should submit a selfattested copy of valid caste certificate specifically mentioning Creamy Layerexclusion in the format prescribed by Govt. of Gujarat.
- 24. EWS vacancies are tentative and subject to further directives of GoG and outcome of any litigation. The appointment is provisional and it is subject to the Income and Asset certificate being verified through proper channel and if the verification reveals that the claim to belong to EWS is fake/false, the services will be terminated forthwith without assigning any further reasons and without prejudice to such further action as may be taken under the provision of the Indian Penal Code (IPC) for production of fake/false certificate.

- 25. The qualifications and other conditions prescribed in the present advertisement are subject to the regulations/norms stipulated by the UGC/NCTE other relevant apex bodies from time to time.
- 26. Under the term 'good academic record' the candidates must have obtained at least 55% marks (or an equivalent grade in a point scale wherever grading system is followed) at the Master's degree level, or an equivalent degree from an Indian/Foreign University.
- 27. The prescribed qualifications and experience are minimum and the mere fact that a candidate possesses the same will not entitle him/her for being called for interview.
- 28. The University reserves the right to restrict the candidates to be called for interview to a reasonable number on the basis of qualifications and experience higher than the minimum prescribed as decided by duly constituted Screening Committee(s) and approved by the competent authority. Call letters for attending interview will be sent only to the short-listed candidates by Speed Post/RPAD/E-mail. No correspondence will be entertained with applicants who are not short-listed to be called for interview.
- 29. Canvassing in any form on behalf of or by any candidate will disqualify him/her from being considered.
- 30. Selection will be made on the basis of candidates' overall record and performance in the interview. The University may utilize seminar /colloquium and/or any other mode as a method of selection.
- 31. Candidates already in service must submit an NOC from their employer and forward their applications (hard copy) through proper channel. In case the applicants are in service and delay is expected in getting endorsement of the employer concerned on the original application, the applicants may submit an advance copy of the application alongwith all enclosures directly (with or without the employer's endorsement on the advance copy). If the original application through proper channel has not been received by the University till the last date mentioned in this employment notification, the applicants will have to submit a 'NO OBJECTION CERTIFICATE' alongwith Vigilance Clearance Certificate from his/her employer to the University at the time of interview.
- 32. Incomplete application in any respect will not be considered.
- 33. Notwithstanding anything contained herein, the University reserves the right to:

 (a) offer the post at the level lower than that advertised depending upon the

- qualifications, experience and performance of the candidates, by relaxing any of the requirements;
- (b) draw reserve panel(s) against the possible vacancies in the future
- (c) consider "in-absentia" the candidature of those who may or may not have applied, or may have applied for higher positions;
- (d) relax any of the qualifications/experience at its discretion and in not to fill-up any or all of the advertised positions.
- 34. The candidates selected shall be appointed under a written appointment letter as per University/GoG/UGC norms.
- 35. The Candidate Selected for the post shall be required to serve at any place notified as the Campus of K.S.K.V. Kachchh University.
- 36. The selected candidate will be required to perform duties as per the rules of University as amended from time to time. The University is free to assign any duty as per the exigency of the situation at any time even during non-working hours/holidays which the employee has to perform without fail to avoid disciplinary action in this regard.
- 37. Appointed Teachers may be assigned other academic or administrative responsibilities in addition to their regular teaching and research.
- 38. The selected candidate including in-service candidate shall be governed by the Act/Statutes/Ordinances/Regulations/Rules of the Krantiguru Shyamji Krishna Verma Kachchh University and amendments from time to time and any other Rules/Regulation as per prescribed specially for the maintaining the code of conduct of the employee by the University.
- 39. Every person appointed permanently to a post in the University by direct recruitment, shall be on probation in such post for a period of one year in the first instance, provided that the appointing authority may, in any individual case, extend the period of probation to such extent as it may deem necessary, the reasons thereof to be recorded in writing.
- 40. Where a person has not completed his period of probation satisfactorily, the appointing authority may terminate his services under the University without notice and assigning any reason thereof.
- 41. The medium of instructions in respect of all courses conducted in the Centers and Departments, admitted to the privileges of the University shall be Gujarati, except in cases of studies / research in languages.
- 42. The recruitment to the advertised posts shall be carried out in accordance with the prevalent University/UGC/GoG norms.

- 43. Age of superannuation for all the positions shall be as per Govt. of Gujarat norms.
- 44. All the appointees' candidates shall be governed by the Pension Scheme introduced and approved by Govt. of Gujarat.
- 45. In case of any dispute, any suite or legal proceeding by or against the University. Courts within whose local jurisdiction, Headquarter of the University is Situated shall have the jurisdiction.
- 46. The University reserves the right:

- 52. The applications received shall be screened as per screening guidelines published in UGC Regulations, 2018.
- 53. No person shall be recruited unless he/she is in good mental and bodily health and free from any physical defect that is likely to interfere with the efficient performance of his official duties. - produce a medical certificate of physical fitness certificate from whom the appointing authority specifies.

Minimum Qualifications and Experience

The terms and conditions with regards to the minimum qualifications and other terms and conditions as the UGC Regulations ON MINIMUM QUALIFICATIONS FOR APPOINTMENT OF TEACHERS AND OTHER ACADEMIC STAFF IN UNIVERSITIES AND COLLEGES AND MEASURES FOR THE MAINTENANCE OF STANDARDS IN HIGHER EDUCATION 2018 and amendments from time to time, shall be followed.

Qualifications for the Post of: Assistant Professor/Associate Professor/Professor

1. Faculty of Arts, Sciences and Commerce & management are as under:

1.1.1 ASSISTANT PROFESSOR

Eligibility (A or B):

A.

- (i) Consistently Good Academic record in Master's degree with 55% marks (or an equivalent grade in a point-scale wherever the Grading System is followed) in a concerned/relevant/allied subject from a recognized Indian University, or an equivalent degree from an accredited foreign university.
- (ii) Besides fulfilling the above qualifications, the candidate must have cleared the National Eligibility Test (NET) conducted by the UGC or the CSIR, or a similar test accredited by the UGC, like SLET/SET or who are or have been awarded a Ph. D. Degree in accordance with the University Grants Commission (Minimum Standards and Procedure for Award of M.Phil. /Ph.D. Degree) Regulations, 2009 or 2016 and their amendments from time to time as the case may be exempted from NET/SLET/SET:

Provided, the candidates registered for the Ph.D. programme prior to July 11, 2009, shall be governed by the provisions of the then existing Ordinances/Byelaws/Regulations of the Institution awarding the degree and such Ph.D. candidates shall be exempted from the requirement of NET/SLET/SET for recruitment and appointment of Assistant Professor or equivalent positions in Universities/Colleges/Institutions subject to the fulfillment of the following conditions:-

a) The Ph.D. degree of the candidate has been awarded in a regular mode;

- **b)** The Ph.D. Thesis has been evaluated by at least two external examiners;
- c) An open Ph.D. viva voce of the candidate has been conducted;
- **d**) The Candidate has published two research papers from his/her Ph.D. work, out of which at least one is in a refereed journal;
- e) The candidate has presented at least two papers based on his/her Ph.D. work in conferences/ seminars sponsored/ funded/ supported by the UGC/ICSSR/CSIR or any similar agency.

The fulfillment of these conditions is to be certified by the Registrar or the Dean or H. O. D. of the University concerned.

Note:

NET/SLET/SET shall also not be required for such Masters Programmes in disciplines for which NET/SLET/SET is not conducted by the UGC, CSIR or similar test accredited by the UGC, like SLET/SET.

The Ph.D. degree has been obtained from a foreign university/institution with a ranking among top 500 in the World University Ranking (at anytime) by any one of the following: (i) Quacquarelli Symonds (QS) (ii) the Times Higher Education (THE) or (iii) the Academic Ranking of World Universities (ARWU) of the Shanghai Jiao Tong University(Shanghai).

1.2 ASSOCIATE PROFESSOR

- (i) Consistently good academic record with a Ph.D. Degree in the concerned/allied/relevant Disciplines.
- (ii) A Master's Degree with at least 55% marks (or an equivalent grade in a point scale wherever Grading System is followed).
- (iii) A minimum of eight years of experience of teaching and / or research in an academic/research position equivalent to that of Assistant Professor in a University, College or Accredited Research Institution/industry with a minimum of seven publications in the peer-reviewed or UGC-listed journals and a total research score of Seventy-five (75) as per the criteria given in Appendix II, Table 2 (UGC regulation 2018).

1.3 PROFESSOR:

Eligibility (A or B)

A.

- (i) An eminent scholar having a consistently Good Academic record with a Ph.D. degree in the concerned/allied/relevant discipline, and published work of high quality, actively engaged in research with evidence of published work with, a minimum of 10 research publications in the peer- reviewed or UGC-listed journals and a total research score of 120 as per the criteria given in Appendix II, Table 2 (UGC regulation 2018).
- (ii) A minimum of ten years of teaching experience in university/college as Assistant Professor/Associate Professor/Professor, and / or research experience at equivalent level at the University/National Level Institutions with evidence of having

OR

B. An outstanding professional, having a Ph.D. degree in the relevant/allied/applied disciplines, from any academic institutions (not included in A above) / industry, who has made significant contribution to the knowledge in the concerned/allied/relevant discipline, supported by documentary evidence provided he/she has ten years' experience

2. Faculty of Education is as under:

2.1 Associate Professor:

(1) A Master's Degree in Arts/ Humanities/ Sciences/ Commerce and M.Ed. each with a minimum of 55% marks (or an equivalent grade in a point scale wherever grading system is followed)

OR

M.A. (Education) and B.Ed. with 55% marks in each (or an equivalent grade in a point scale wherever grading system is followed)

- (2) Ph. D in Education as per norms
- (3) A minimum of eight years of experience of teaching and / or research in an academic/research position equivalent to that of Assistant Professor in a University, College or Accredited Research Institution with a minimum of seven publications in the peer-reviewed or UGC listed journals and a total research score of Seventy five (75) as per the criteria given in Appendix II, Table 2 (UGC Regulation 2018).
